## **Cockburn Basketball Association – Wally Hagan Stadium – Conditions of Entry**

**Cockburn Basketball Association (CBA) is committed to providing a safe, healthy and enjoyable environments for all patrons and staff.**

In support of this, entry into Wally Hagan Stadium is subject to specific conditions.

### **1. Additional Conditions of Entry:**

- May vary according to the types of programs, activities and services
- Are subject to the requirements of CBA management and Government direction

**Standard Conditions of Entry will remain in force and applied in conjunction with Government restrictions.**

### **2. Rights of Management – Wally Hagan Stadium will refuse entry to any person:**

- If the maximum number of people in the venue and/or facilities within has been reached
- Wishing to access an aspect of the venue or its services which are not currently operational
- Unauthorised access to the venue
- Deemed to be intoxicated, disorderly or engaging in anti-social behaviour
- Subject to an existing ban

### **3. Screening**

- It is a condition of entry that all patrons consent to having their bags, clothing or other items checked on entry or within Wally Hagan Stadium anytime
- Any person who fails to comply with screening requests may be refused entry or removed from Wally Hagan Stadium



#### **4. Prohibited Conduct / Patron Removal**

- A person may be removed from Wally Hagan Stadium where they enter an area of Wally Hagan Stadium without proper authorisation
- Fail to comply with a lawful request from staff or authorised personnel
- Use foul or abusive language or making racial, discriminatory, or threatening remarks or gestures
- Are under the influence of alcohol or illicit drugs and/or engage in disorderly, offensive, anti-social, disruptive, or unlawful behaviour
- Commit any act of vandalism or littering or damage property

No refunds will be paid to persons removed from Wally Hagan Stadium. Persons may be referred to police as deemed appropriate by CBA management.

#### **5. Electronic Surveillance**

To enhance security, protect the safety of persons and ensure compliance with these conditions, surveillance equipment (including security cameras via CCTV) are in operation within and in surrounding areas of Wally Hagan Stadium.

By entering Wally Hagan Stadium, persons give consent to their information (including images) being recorded and disclosed to third parties including law enforcement agencies and governing organisations holding events.

All personal information is managed in accordance with the Privacy Act WA 1996.



## **6. Risk and Liability**

Persons enter Wally Hagan Stadium at their own risk.

Each person assumes all risk of any damage or loss (including property damage, personal injury, economic and consequential loss) however it arises at Wally Hagan Stadium.

Each person brings personal effects into Wally Hagan Stadium at their own risk and neither Cockburn Basketball Association nor the hirer will be responsible for any damage to or loss or theft of personal property.

## **7. Compliance**

By entering Wally Hagan Stadium, you are agreeing to comply and cooperate with the Conditions of Entry.

Failure to comply with directions may be considered an offence under the Emergency Management Act 2005.

## **8. Attire**

As a minimum for general public areas, patrons must be appropriately clothed with clothing suitable to the activity in which they are participating.

Patrons wearing or displaying inappropriate or unauthorised commercial, political, religious images/logos etc. that are offensive may be denied entry or asked to remove such items.

Wearing of 'colours' or 'insignia' belonging to any Outlaw Motorcycle Clubs or other groups as designated by Police is prohibited.

Patrons attempting to conceal their identity with a scarf, balaclava, mask or other item unless for a religious or medical or other justifiable reason may be refused entry, undergo a security check and/or be removed from the facility.



## 9. Prohibited Items

The following items are prohibited from entering Wally Hagan Stadium unless specifically authorised by CBA management:

- Weapons of any kind
- Alcohol and drugs
- Cans and glass
- Musical instruments / whistles
- Unauthorised temporary signage and promotional products
- Flags / banners over 1 metre
- Fireworks / flares / laser lights / Pyrotechnics
- Rollerblades / skateboards / scooters / helmets
- Professional camera, audio recording equipment or video cameras
- Animals except for authorised assistance animals
- Any large items that cannot be placed under a seat
- Umbrellas
- Prams
- Any other item that in the opinion of CBA could cause damage, harm or public nuisance

## 10. Alcohol

Wally Hagan stadium is licensed and as such the following provisions apply:

- Alcoholic beverages must not be taken into or out of the Wally Hagan Stadium
- Alcohol, if served, must only be consumed in the designated areas
- Alcohol must not be consumed in designated 'Alcohol Free' areas
- It is an offence for minors to purchase or consume alcohol, or for a person to supply an alcohol to a minor

Breaches of these conditions may result in the persons being reported to the Police and removal from Wally Hagan Stadium (penalties apply under the Liquor Licensing Act 1988).



## **11. Food and Non-Alcoholic Drinks**

Deliveries and product from external caterers and commercial outlets are generally not permitted in Wally Hagan Stadium.

Decisions about whether such products will be permitted are at the discretion of the hirer and CBA management.

Patrons may bring homemade food items to the venue provided it is packed appropriately and can be viewed by staff or security personnel if requested.

This does not apply to food or beverages for patrons with special dietary requirements, provided that such food or beverages are not packaged in prohibited containers.

Thermoses containing tea and coffee may be allowed but may be checked for liquor licensing purposes.

## **12. Smoking**

Smoking is not permitted anywhere in Wally Hagan Stadium, except in designated smoking areas.

This includes electronic cigarettes, personal vaporisers, electronic nicotine delivery systems or other battery powered vaporisers.

## **13. Tickets**

Tickets must be retained at all times (if applicable).

Where the ticket is for general admission, no representation is made that there is seating available within Wally Hagan Stadium.

## **14. Underage Persons**

Patrons under the age of 12 years of age must be under the direct supervision of an adult parent or guardian at all times, unless enrolled in a CBA program.



## 15. Use of Image

By entering the venue, patrons give consent to their image, likeness or voice being captured and used as part of any recording of an event or any other purpose without compensation of any kind.

## 16. Photographic, Video and Audio Equipment

Cockburn Basketball Association requires members, parents, carers, and guests obtain permission from a child's parent/guardian before taking an image of a child that is not their own.

***They must also make sure the parent/guardian understands how the image will be used.***

A person is permitted to video/photograph games involving minors if they are:

- a) related to a player involved in the game (or guardian), or
- b) approved by the Referee Coordinator for referee development/education.

The use of photographic, video or audio equipment (including mobile phones with camera interfacing) is not permitted:

- For commercial purposes without prior authorisation from the hirer or CBA management
- In the following specified public areas of Wally Hagan Stadium:  
Change rooms  
Toilets / showers





### ***Non-Compliance***

- Any member found to be taking photos or filming without the appropriate permissions will be asked to cease immediately and seek the appropriate permissions to continue/keep already taken images/footage. If permission is not granted, already taken images/footage must be deleted.
- Any member who continues to take photos/footage without permission or refuses to delete already taken photos/footage may be asked to leave and refused re-entry at any other time.
- The taking of photos/footage and its use under certain circumstances is a criminal offence that can be reported by victims to the police.
